	4)	SATISFACTORY PROGRESS IN FUTURE TERMS - If I do not make satisfactory progress or meet the conditions/terms outlined in my appeal approval during the next semester, my financial assistance will be terminated at ICC.			
	5)	TERMINATION - Failing to meet the conditions/terms of the probation will result in being placed on termination.
